



## RENTAL AGREEMENT AND RELEASE OF LIABILITY

1. I accept for use the equipment listed on this form "as is," and accept full responsibility for the care of this equipment while it is in my possession.
2. I have made no misrepresentations to Straightline in regard to my height, weight, age or skier type.
3. I understand that the ski-boot-binding systems will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and is therefore no guarantee for my safety.
4. I understand that there are other ski equipment rental businesses in close proximity to Straightline.
5. I understand that there are inherent and other risks involved in the sport for which this equipment is to be used, snow skiing, including but not limited to changing snow conditions, collisions with trees, rocks and manmade objects, and other skiers. I further understand that injuries are a common and ordinary occurrence of the sport, and I freely assume those risks.
6. I agree to hold harmless and indemnify Straightline and it's owners, agents and employees for any loss or damage, including any that results from claims for personal injury or property damage related to the use of this equipment, except reasonable wear and tear.
7. I hereby release Straightline and it's owners, agents and employees from any and all liability for damage and injury to myself or to any person or property resulting from negligence, installation, maintenance, the selection, adjustment and use of this equipment, and I accept the full responsibility for any and all such damage or injury which may result.
8. MY INITIALS VERIFY THAT THE VISUAL INDICATORS ON MY BINDINGS CORRESPOND TO THE SETTINGS AS SHOWN ON THIS RENTAL AGREEMENT.
9. ALL INSTRUCTIONS ON THE USE OF MY RENTAL EQUIPMENT HAVE BEEN MADE CLEAR TO ME, AND I UNDERSTAND THE FUNCTION OF MY EQUIPMENT.
